REGULATIONS FOR REGISTRATION OF PARTICIPANTS OF
THE EASTERN CONGRESS OF YOUNG LEADERS

1. GENERAL PROVISIONS

1.1. The Eastern Congress of Young Leaders in the further part of the Regulations – CONGRESS takes place on 27-29 May 2026 in Lublin and Nasutów.

1.2. The CONGRESS ORGANIZER is the European Meeting Centre– Nowy Staw Foundation with its registered office in Lublin at 3 Maja 18/5a, 20-078 Lublin, NIP: 946-17-71-036, hereinafter referred to as the ORGANIZER.

1.3. As part of the CONGRESS, the following will be held:

- a. plenary sessions
- b. panel discussions
- c. workshops
- d. other forms of meetings

1.4. The provisions of these Regulations constitute an integral part of the Application for Participation in the CONGRESS and apply to all Participants.

1.8. These regulations apply to participation in the CONGRESS in a stationary form, the event will not be held online.

2. RULES OF PARTICIPATION

2.1. AN ACCREDITED PARTICIPANT OF THE CONGRESS, hereinafter referred to as PARTICIPANT, will be a person who has passed all stages of registration and received confirmation of qualification to participate in the CONGRESS.

2.2. The condition for participation in the stationary form in the CONGRESS is to submit your participation only via the application form: <https://forms.gle/GGQBpS6FxBZ8zmS5A>

The registration consists of two stages: I of them is filling in the application form, and II – conducting the selection of participants by the organizer and contact with qualified persons.

2.3. The first stage of registration of stationary participation consists in filling in the registration form by providing personal and contact data and consenting to the processing of the above-mentioned data by the CONGRESS ORGANIZER;

2.4. Filling in the registration form means acceptance of the regulations.

2.5. After full registration, a confirmation will be sent to the e-mail address provided by the participant during registration. If you do not confirm any of the above, your registration may fail due to technical problems with your browser. The obligation to verify this fact rests with the participant of the CONGRESS.

2.6. Due to the limited number of participants, the CONGRESS ORGANIZER reserves the right to refuse to accept the application for participation in the CONGRESS without giving a reason.

2.7. The organizer decides on the closing date of the registration. The deadline for completing registration is subject to change.

2.8. The first stage of registration of stationary participation will be closed on May 4, 2026.

2.9. The second stage of registration of stationary participation will be closed on May 8, 2026.

3.1. ACCREDITED PARTICIPANT OF THE CONGRESS in a stationary form receives a personal ID with a photo that entitles them to move around the CONGRESS venue where the CONGRESS takes place.

3.2. AN ACCREDITED PARTICIPANT OF THE CONGRESS in a stationary form is obliged to have the CONGRESS ID provided to him throughout his stay in the facilities where the program events of the CONGRESS take place and is always obliged to present it at the request of the representative of the ORGANIZER.

3.3. Admission to the facilities where the program events of the CONGRESS take place is granted only to ACCREDITED CONGRESS PARTICIPANTS.

3.4. Persons who are unable to present their CONGRESS ID during their stay in the facilities where the CONGRESS program events are held are obliged to leave these facilities immediately at the request of the ORGANIZER's representative.

3.5. The ORGANIZER has the right to take away the CONGRESS ID if it is used by a person other than the ACCREDITED CONGRESS PARTICIPANT shown on the CONGRESS ID in the facility where the program events of the CONGRESS are held.

3.6. Persons who have lost their CONGRESS ID in some way may receive its duplicate in accordance with the instructions provided by the ORGANIZER.

3.7. The ORGANIZER shall not be liable for statements and presentations presented during the program events of the CONGRESS.

3.8. ACCREDITED PARTICIPANT OF THE CONGRESS bears full responsibility for all his statements and presentations presented during the CONGRESS.

3.9. The ORGANIZER is not responsible for items belonging to ACCREDITED CONGRESS PARTICIPANTS that may be lost, destroyed, or stolen during the CONGRESS.

3.10. AN ACCREDITED PARTICIPANT OF THE CONGRESS is obliged to cover all costs related to repairing the damage caused by him, which will be incurred by the ORGANIZER in

the event of third parties claiming against the ORGANIZER related to damages caused by the CONGRESS PARTICIPANT.

3.11. ACCREDITED PARTICIPANT OF THE CONGRESS is obliged to comply with the OHS safety rules and fire regulations that apply in the facilities where the program events of the CONGRESS take place, as well as instructions and organizational, technical instructions of the representatives of the ORGANIZER.

3.12. The representative of the ORGANIZER during the CONGRESS is considered to be any person holding a personal CONGRESS ID with the inscription ORGANIZER.

3.13. The CONGRESS partners are informed by the ORGANIZER that they may not conduct marketing activities toward the CONGRESS Participants that are unethical or violate legal and moral norms.

3.14. All promotional activities of the Partner must be discussed with the ORGANIZER in advance.

3.15. The CONGRESS is a closed event.

4. LIABILITY

4.1. The Organizer is not responsible for:

- a) incorrectly entered data by the Participant,
- b) lack of access to the Internet makes it impossible to register or limit its availability,
- c) damages incurred and profits lost by the Participant, the Buyer, or third parties, which were caused as a result of providing false data by the person making the Registration;
- d) damages incurred and profits lost by the Participant, the Buyer, or third parties, which were caused as a result of acts or omissions of third parties beyond the control of the Organizer,
- e) damages incurred and profits lost by the Participant, Buyer, or third parties, which were caused as a result of the cancellation of the Eastern Congress of Young Leaders by the Organizer as a result of force majeure (random events beyond the control of the Organizer).

6. RESIGNATION FROM PARTICIPATION AND REPLACEMENT IN THE APPLICATION FOR PARTICIPATION

6.1. The participant's resignation from participation in the CONGRESS must be made in writing and must be sent to the following e-mail address: kongres@eds-fundacja.pl in the subject: "Resignation" by May 8, 2026 r.

6.2. The ORGANIZER reserves the right to change the date of the CONGRESS for reasons beyond its control.

7. INTELLECTUAL PROPERTY

7. 1. The title and program of the Eastern Congress of Young Leaders, including the website, layout, log, graphics, photos, audio and video files used for the promotion of the conference, as well as presentations, are vested in the Organizer or a third party (if it has been marked as such) and are legally protected.

7. 2. The above designations and materials may not be used without the written consent of the Organizer or a third party who is the owner of the rights, in particular, they may not be used in connection with products or services of third parties in a way that may mislead potential customers of the Organizer or otherwise harm the Organizer. Copying conference materials and/or recording the Conference (without the consent of the Organizer), as well as making such materials and recordings available is illegal and subject to criminal liability in accordance with the Act of 4 February 1994 on Copyright and Related Rights.

7. 3. Neither the participant nor any third party may remove, obscure, prevent or alter the trademarks, copyright notices, or other proprietary notices contained in any materials related to the Eastern Congress of Young Leaders.

8. COMPLAINTS

8.1. All complaints should be sent in writing by registered mail to the address of the ORGANIZER within 7 days from the date of the end of the CONGRESS.

8.2. Complaints sent after the above deadline will not be considered.

8.3. Complaints will be considered by the ORGANIZER within 30 days from the date of their receipt, and the response to them will be sent in writing to the address indicated by the complainant.

9. FINAL PROVISIONS

9.1. The ORGANIZER reserves the right to change the substantive program of the CONGRESS.

9.2. The ORGANIZER reserves the right to cancel the CONGRESS in the event of random events beyond the control of the ORGANIZER.

9.3. In the event that the CONGRESS does not take place for reasons beyond the control of the ORGANIZER, the Participant is not entitled to compensation or reimbursement of any fees related to Participation in the CONGRESS, as well as the costs of additional services commissioned to the ORGANIZER by the CONGRESS Participants.

9.4. The ORGANIZER sets the program of the CONGRESS and has the right to make changes to it also on the day on which the CONGRESS takes place, including the right to change the time schedule, order of speeches, selection, and change of speakers.

9.5. The ORGANIZER shall not be liable for the inability of the participant to participate in the CONGRESS caused by force majeure or caused by the fault of the participant.

9.6. In case of doubts as to the interpretation, the text of the Regulations in Polish is the binding version.

9.7. Failure to comply with the provisions of these Regulations, instructions of the Organizer's representatives, and inappropriate behavior of the Participant, including conducting demonstrations disrupting the course of the Forum, bringing alcohol, psychoactive substances, smoking tobacco and electronic cigarettes in places not intended for this purpose,

any manifestations of disrupting the course of the CONGRESS, the creation of emergency situations shall give rise to disciplinary measures in the form of:

1. admonitions,
2. immediate removal of the Participant from the CONGRESS area by the representatives of the Organizer without the right of return and without the right to demand reimbursement of any costs incurred or expenses related to participation in the CONGRESS,
3. Notifications to competent law enforcement authorities.

9. 8. Any disputes that may arise from the Participation in the CONGRESS shall be settled by the court competent for the seat of the ORGANIZER.

9. 9. Sending a registration application from the website of the CONGRESS means acceptance of the provisions of these Regulations, as well as compliance with order regulations and any other arrangements between the Participant and the ORGANIZER.

9.10. In matters not covered by these Regulations, the provisions of the Civil Code shall apply.

9.1 1. The final interpretation of these regulations belongs to the ORGANIZER.

9.12. The Organizer reserves the right to make changes to the regulations, about which it will inform the Participants by publishing a new text of the Regulations on the: <http://www.edsfundacja.pl/projekty/mds/index.php> website.

9.13. If the Participant does not agree to the new provisions of the Regulations, he should report his resignation to the Organizer by e-mail to the following address: kongres@edsfundacja.pl

9.14. In accordance with the Act on the Protection of Personal Data of 29 August 1997 (Journal of Laws 133 of 29 October 1997, item 833.) The CONGRESS ORGANIZER does not transfer, sell or lend the collected personal data of the Participants to other persons or institutions. Personal data provided by the Participant (name and surname, address, telephone number, e-mail address) are treated as confidential information and are used only for the purpose of communication between the Participant and the CONGRESS ORGANIZERS.
